## Purchase of Exclusive Right of Burial (Transfer)

This constitutes the purchase of the lease of the Exclusive Right of Burial in a grave space, the period for which is stated in the original Grant of Exclusive Right of Burial Deed and is from the original date of purchase.

The Owner of the Exclusive Right of Burial is known as the Grant Holder.

The Cemetery Regulations clearly outline the role and responsibilities of both the Grant Holder and the Council in relation to the Exclusive Right of Burial in the allocated Grave Space.

The Regulations cover important issues such as Council fees and charges, transfer and renewal of right of burial, interments, memorial restrictions and conditions, insurance, planting and maintenance.

The Cemetery Regulations are issued in conjunction with this Purchase Agreement and are available at any time from the Council office and website [www.dursleytowncouncil.gov.uk](http://www.dursleytowncouncil.gov.uk)

It is important that the original Grant of Exclusive Right of Burial Deed and/or transfer documents are kept in a safe place as they are the only legal documents confirming entitlement to the Right.

Subject to Council agreement, the Grant Holder is the only person who can authorise / request subsequent interments (up to the maximum indicated by the description of the plot), erection of a memorial and works / alterations to an existing memorial.

It is very important that the Grant Holder informs the Council of any change of address.
